



BASE 43 LIVING ROOM OF AUTUMN OF IT PHOTOGRAPHS INTERNATIONAL BIENNIAL V

REGULATION:

This regulation has been made according to the norms and recommendations of the FIAP, CEF and FVF.

This competition enjoys the patronage of the F.I.A.P (2009/125) and of the C.E.F. (I/2009/7) and, therefore it will be governed by its respective norms and it will be puntuable for the obtaining of its honorary titles.

1. - PARTICIPANTS:

Photographers from all over the world that they appeal to the picture like half of artistic expression; nevertheless the organization and the committee classifier will be able to reject an inscription that, to its discretion, don't fulfill the norms and conditions that govern it, or its works attempt against the morals or the ethics.

2. - DISCIPLINES:

Digital files.

It will be admitted any technique and the manipulation of the files by means of programs appropriate computer specialist.

3. - YOU CUT:

- a) monochrome digital Files.
- b) digital Files in color.

4. - FEARS:

Free in all their aspects, with or without thematic unit.

5. - WORKS:

Each author will be able to present as maximum a collection from three to five pictures for section. The presented pictures have been reward in any other national or international contest neither presented previously to organized living rooms by AGFOVAL.

Each participant's works, in each section, they will be presented to the judges consecutively in the order pointed out by the author.

All the images will be original of the own author and they won't be able to incorporate elements taken place by other people. The organization doesn't assume responsibility some for undue use of the royalties for the participant. Any modification or manipulation of the original image will be carried out by the author.

6. - SIZE AND PRESENTATION:

The support, CD or DVD will go identified with indelible ink with the SIGNATURE and the ALIAS adopted by the author and it will consist of two denominated different portfolios LOW and HIGH.

Of each image two files will be burdened; one in LOW, for the verdict, in format JPG of 1.024 pixels of long if the format is horizontal or of 768 pixels of high if the format is vertical (80 ppp); and another in HIGH, for its possible publication or impression, in format TIF or JPG to maximum quality (600 ppp), of 4.096 pixels like minimum the smallest side.

7. - IDENTIFICATION:

The digital files will be identified with the author's alias, the section and the order number, in accordance with the inscription bulletin (Example: alias _A_1, alias _A_2 / alias _B_1, alias _B_2.... Etc.).

8. - BULLETIN OF INSCRIPTION:

Each author will accompany the support (CD or DVD) of his works with the specific inscription bulletin of the 43 Living room of Autumn that will stuff in uppercase with clear and readable letter. It is necessary to execute the biggest quantity in data possible, and it is OBLIGATORY to include the complete physical address (not the Post Office box) and, at least, A TELEPHONE and the person's operative address of contact E-MAIL that

he/she makes the shipment with their works. These requirements are indispensable to be able to make the refund of the support, shipment of the catalog, trophies and prizes. If all these data are not included in the inscription bulletin, you won't return the support and it won't be sent the catalog neither the prizes that have been obtained.

9. - WAY OF SHIPMENT:

Inside the envelope the support will be included (CD or DVD), it copies of the voucher of payment of the rights or transfer order and another closed envelope, identified with the ALIAS, with the inscription bulletin.

10. - RIGHTS OF PARTICIPATION:

- a) For a section (A or B), 25 € or 35 \$it USES.
- b) For the two sections (A and B), 30 € or 40 \$it USES.

In the whole cases, the participant should make sure that the Organization will receive the entire amount of the rights, running all the expenses, costs or commissions in charge of who makes the shipment. **Checks are not accepted.**

With independence in the chosen payment way, besides the personal data of who makes the shipment, inexcusably, it will be made consist the elected ALIAS.

12. - JURY:

It will be compound for three members of grateful prestige and important knowledge of the international picture, being fulfilled in all moment the minimum requirements settled down by the International Federation of the Photographic Art (FIAP).

They will be those in charge of awarding the prizes and it will select the works that you/they will appear as much in the catalog as in the exhibition. The decision of the jury will be inappealable. The relationship of the winners and the selected works will be published in our page Web.

The Organizing Committee will be formed by the Directive Meeting of AGFOVAL and it will be taken charge of veiling that the presented works fulfill the requirements of these bases and of informing to the Jury those that, to its approach, they don't complete it for its decision.

13. - PRIZES:

To the group of three to five pictures, in each one of the sections A and B.

" PRIZE OF HONOR: Medal of Honor of the F.I.A.P. and Trophy AGFOVAL

" FIRST PRIZE: Medal of Silver of the F.I.A.P. and Trophy AGFOVAL

" SECOND PRIZE: Medal of Brass of the F.I.A.P. and Trophy AGFOVAL

" 6 mentions of Honor F.I.A.P. and medal AGFOVAL, to election of the jury.

To the best works, in each one of the sections A and B.

" PRIZE OF HONOR: Medal of Honor of the C.E.F. and Trophy AGFOVAL

" FIRST PRIZE: Medal of Silver of the C.E.F. and Trophy AGFOVAL

" SECOND PRIZE: Medal of Brass of the C.E.F. and Trophy AGFOVAL

Special prizes to the best picture-clubs:

They will be granted to the associations or picture-clubs that obtain more quantity of accepted works among all their members.

" Golden medal of AGFOVAL and diploma

" Silver medal of AGFOVAL and diploma

" Tan medal of AGFOVAL and diploma.

The Organized Committee is reserved the ability to acquire work presented to the competition, accepting the contestants the specified price of 30 € (thirty Eurus) for acquired work.

The Prize of Honor, First and Second Prize, in each category, as well as the acquired works will be in property of the Agrupación Fotográfica Valenciana (AGFOVAL).

14. - I CLASSIFY:

It will be published in impression to four inks and in digital support (DVD), sponsored by the Area of Culture of the City council of Valencia. In them they will appear reproduced the winning works, the exposed ones and those selected for the catalog.

A printed copy will be sent to each one of the winning participants and a copy in digital support to each one of the participants that you/they have paid the rights and fulfill the present Regulation totally.

15. - CALENDAR OF THE LIVING ROOM:

TERM OF ADMISSION: Until the day November 21 2.009.

VERDICT OF THE JURY: The day November 28 2.009 (Saturday) at the 10:30 hours in the headquarters of "AGFOVAL."

EXHIBITION: He/she will be carried out, in date to determine, in the House Museum Mariano Benlliure and in her the winning works will be exposed, those selected for the catalog and the elects by the Jury to such an end.

REFUND OF THE WORKS: In the term of 45 days starting from the closing of the exhibition and the catalog is in our power.

16. - SURRENDERS OF THE PRIZES:

The same day of the inauguration of the exhibition, what will communicate for the quickest means to the interested ones, preferably via e-mail.

17. - REPRODUCTION OF THE WORKS:

By virtue of their inscription, all participant certifies each work like own and you/he/she authorizes the organizers the exhibition and the reproduction of her total works or partially, without limitation of systems, means, neither countries, without payment of rights.

The participants take the responsibility totally of the rights of third and of any reclamation for image rights.

The works that don't fulfill all the requirements of the present regulation won't be subjected to the consideration of the Jury, neither their author will be entitled to catalog.

The organization will try with the maximum care the supports (CD or DVD) that he/she receives, but it declines any responsibility in the event of loss, robbery, deterioration, reproduction impossibility, fire or damages caused during its manipulation, transport or exhibitions.

With their participation, each contestant recognizes to accept all the conditions of the present regulation and she manifests, expressly, to be the author of the works that remits.

Their data will be registered in the file "Shipment of Bases of Competitions and Marathons" of exclusive use of "AGFOVAL". If you want to exercise their access right, rectification or cancellation, he/she should go in writing, fax or and e-mail, to the General Secretary of "AGFOVAL."
